Secretary - Susan S. read secretary's report. Elizabeth O made motion to accept w/corrections. Carl B 2nd. Passed, unanimous.

Treasurer - Teri F. read report (see attached). \$4617.10 beginning balance. Paid out \$1886.29. Revenue \$ 4754.16. Expenses \$1784, ending balance \$7484.97.\$92 less so has corrected it. We are balanced. Elizabeth O. made motion to accept, Carl B 2nd. Passed unanimous.

H&I - Jimmy E. gave report (see attached). Holding workshop tonight at Newcomers . Jennifer C starting meeting at Canadian County jail in El Reno. Read qualification to carry meeting - off paper for year, no violent or sex offenses. Will be getting schedules into facility.

PR - Jim G made report (see attached). Have talked about issues that need to be looked at. Inconsistencies with website, will get with Ricky about it. Has been asked to put ODOC application on website. Going to continue one more month with current phone line set up. Has documents with phone numbers from Stan and will be working to put people on. E Can we go through H&I to go to school superintendents to carry message to at-risk kids. Steve O said that is part of PR, not H&I. Said he did not think we should address the addict who broke anonymity at level of press. Bill F brought up old PI panels, suggested getting young people on panels. Ricardo talked about Young People's group in Eastern Area.
